Congress Approves IRA Rollover Tax Break!

Congress just authorized the IRA Charitable Rollover through December 31, 2014. Donors age 70.5 or older may transfer up to \$100,000 from their IRA to a qualified public charity free of federal income tax. The gift also qualifies as your 2014 required minimum distribution. During the meeting, we visited Fort Southwest Point, located near the junction of the Tennessee and Clinch Rivers. The fort was a prominent resource for securing Expedition members Hall, Howard, Potts, and Warfington. Trent Strickland led a dedication ceremony for three newly installed signs describing the role of Fort Southwest Point in the Lewis and Clark story and honoring the recruits from the fort who joined the expedition.

The Portage Route Chapter will hold a Regional Meeting for all Montana Chapters in conjunction with the Lewis and Clark Festival on June 19 and 20, 2015. Library Update

We thank the Portage Route Chapter (PRC) for the permanent loan of its collection of rare books to the William P Sherman Library and Archives including Frederick Pursh's *Flora Americae Septentrionalis* (1814), George Catlin's *Manners, Customs, and Condition of the North American Indians* (1926 edition), and Alexander MacKenzie's journals (1803) describing his expedition to the Pacific Ocean in 1792 and 1793, as reported on the front page of the Great Falls Tribune. The PRC has also purchased a Rare Books Cabinet to house their rare book collection and the LCTHF rare books in a climate-controlled environment. Library Chair Sue Buchel worked with the PRC and Lindy to select the cabinet. The cabinet will be owned by the PRC and housed at the LCTHF office.

"Supplied for Survival" - 2016 LCTHF Annual Meeting to be in Harpers Ferry National Historical Park from July 24 to 27.

The 2016 Planning Committee chaired by Paige Cruz and including Mike and Lorraine Loesch and Jerry and Janice Wilson met for the third time with the Harpers Ferry park rangers to develop programs, tours, and opportunities to explore this historic area. Merriwether Lewis visited Harpers Ferry in 1803 to secure supplies for the Lewis and Clark Expedition. In addition to the park staff, the Planning Committee is working with the West Virginia office of Tourism to ensure that attendees know all that the area has to offer in terms of history, scenic beauty, and adventure. CA Chapter's Fall Meeting Featured Juan Bautista de Anza National Historic Trail National Park Service (NPS) Ranger Hale Sargent gave an excellent description of the colonizing expedition led by Anza in 1775 and 1776 to the 40 attendees at the meeting held at the Museum of American Heritage in Palo Alto, CA. With his soldiers and their families, Anza traveled about 1800 miles from Sonora in Mexico across Arizona and southern California to the area of San Francisco Bay where he established the first settlement of what is now San Francisco. Amazingly, the only fatality on the expedition was a woman who died in childbirth. The baby survived, however, as another baby had been born along

The 1200-mile Juan Bautista de Anza National Historic Trail goes from Nogales, AZ, to San Francisco, CA. Portions of the trail can be explored by car, foot, horseback, bicycle, and train.
